Breeding regulations for mares to be naturally covered

In order to plan the cover of your mare in the best possible conditions and to prevent any disappointment or delays, we strongly recommend that you send the following documents by email (contact@haras-saintfaust.com) or postal mail **before the cover**:

- the signed nomination contract
- the results of the tests listed below
- a copy of the mare's passport vaccinations pages

Covering sessions take place in the morning (between 9am and 10am) and in the afternoon (between 4.30pm and 5.30 pm).

Mares status

High Risk Mares: those who have had previous contact with CEMO or who originate from or who have been covered in countries outside France, Germany, Ireland, Italy and the United Kingdom in the last 12 months.

Mares that have been tested positive to *K. pneumoniae* ou *P. aeruginosa* are considered High Risk until 3 negative test results have been received, on 3 different cycles during the last two years.

Other mares are considered Low Risk.

If your mare is High Risk, please contact the stud as soon as possible.

Required vaccinations

A copy of the mare's passport is requested, with up-to-date vaccinations against Tetanus, Flu and Equine herpesvirus.

Reminder – WMA protocole :

- *primo-vaccination with 2 injections between 3 and 6 weeks apart*
- *first booster at 6 months*
- *then annual boosters*

Contagious Equine Metritis (CEMO) and other Equine Bacterial Venereal Diseases

Type of swab	Clitoral	Endometrial/Cervical
Tested germs	<i>Taylorella equigenitalis</i> , <i>Klebsiella pneumoniae</i> , <i>Pseudomonas aeruginosa</i>	Others
Barren and maiden mares	After 1st January 2020	During oestrus, after 1st January 2020
In-foal mares	After 1st January 2020	<i>After foaling, please see below</i>
Mares with foal at foot	After 1st January 2020	During oestrus, after 1st January 2020

Equine Viral Arteritis (EVA)

On a sample taken after 1st January 2020:

- one negative blood test (serological test or Elisa) from a certified laboratory
- Seropositive mares will require two blood tests to be taken a minimum of 14 days apart; these should demonstrate a stable or declining titre, from a certified laboratory

Equine Infectious Anaemia (EIA)

It is strongly recommended that you provide a negative blood test for EIA (Coggins) to be taken after 1st January 2020.

It is required for mares coming from abroad.

Please note

- If a mare is changed from one stallion to another during the course of the breeding season a new clitoral swab, endometrial swab and EVA test will be required. These should be taken no sooner than 7 days after the mare was last covered by the original stallion. The previous test results will have to accompany the mare for the cover.
- If a mare changes boarding stud during the course of the breeding season, new tests will be required.
- We would be grateful if mares with hind shoes had them removed before they arrive at the covering shed.
